- Nov. 16, 1943: The Oxnard Harbor District Real Estate Board and the Ventura Real Estate Board are admitted to membership in the National Association of Real Estate Boards.
- Nov. 14, 1967: The Camarillo Board of REALTORS® is admitted to membership in the Nation- al Association of Real Estate Boards.
- Sept. 13, 1996: The Ventura Association of REALTORS®, The Camarillo Association of REALTORS®, and the Oxnard Harbor Association of REALTORS® merge to form the Ventura Association of REALTORS®.
- Sept. 15, 1997: The Association's name is changed to the Ventura County Coastal Association of REALTORS®.







As a REALTOR®, your Code of Ethics certification is a badge that shows your commitment to serving your clients with honesty and integrity. It's essential to keep it up to date!

CODE OF ETHICS COMPLIANCE OPTIONS

As a National Association of REALTORS® (NAR) member, they offer a convenient and free online course for existing members. This course typically takes about 2.5 hours to complete.

As a member of the California Association of REALTORS® (C.A.R.), you get an extra perk – a free 45-hour package of online Continuing Education (CE) courses to help you renew your license. These courses cover all the mandatory subjects and categories required by CalBRE. Plus, they include courses that fulfill the REALTOR® Code of Ethics Training Requirement.

For those of you who are new VCCAR Members, here's what you need to know. You have 30 days to complete the New Member Orientation, MLS Orientation (inperson), and the Code of Ethics (online) class as part of your membership requirements.

Two important things to remember:

- Complete the online NAR Code of Ethics course BEFORE attending the inperson New Member Orientation.
- Once you finish the online course, NAR will provide you with a certificate of completion. Make sure to email this certificate to angel@vcrealtors.com.

These options make it easier to stay compliant with the Code of Ethics and continue to provide top-notch service to your clients!
